THIS AGREEMENT is made on 5th of December, 2012 and between:

Winery&Vineyards, Small Carpathian Vineyard Region
Tehelna 11, 902 01 Pezinok, Slovakia
(the 'Seller');

NOW IT IS HEREBY AGREED as follows:

1. The Seller hereby sells and supply to the Buyer and his/her successors and assigns absolutely, the following wines (the 'Goods'):

2. ORDERS. Each purchase and sale between Buyer and Seller shall be evidenced by an order placed by Buyer to Seller in accordance with the terms and conditions of this Agreement and the shall accept such Orders in writing within 2 working days after receipt of the Order. Each Order shall contain

- A. the Products and the quantity of each Product
- B. the price and
- C. the destination (address) of delivery

3. PRICE. The price the Buyer shall pay for the Goods is the price specified on the Product List at time that Goods are confirmed as ordered.

4. THE QUANTITIES. The Seller will supply to the Buyer Quantity of up to 3000bottles a year.

5. TERMS. This Agreement shall come into force and effect on("Effective Date") and shall remain effective for a period of one (1) year. It shall be automatically renewed, unless any party gives to the other party a written notice not to renew this Agreement at least one (1) month prior to the expiration.

6. PAYMENT. Buyer shall pay to Seller the Price for the Goods ordered within 30 days of receipt of invoice.

7. RETURNS OR REFUNDS. If at any time the Buyer is not satisfied with the quality of the Goods the Buyer has purchased, the Seller will assess the request for a credit, refund or exchange of product of the purchase price. However the Seller cannot guarantee the long time traveling of the wine via ship at not suitable temperature conditions and thus cannot quaratee the same quality as in the winery.
